



**Dublin Heights Community Child Care Inc. 2025 Fee Memo**

DHCCC is enrolled in the Canada-Wide Early Learning and Child Care (CWELCC) funding for families with children 6 years and under. The 2025 CWELCC fee for eligible children is a 52.75% reduction of 2022 fees, and will be at a minimum of \$12.00 per day and capped at a maximum of \$22.00 per day.

Please be advised that there will be a 3% increase to our School-age fees to cover annual inflation. There will be a fee for non-instructional days (P.A. Days, March Break, Winter Break and Summer). If you opt-in for a non-instructional day but do not attend, you are still required to pay the non-instructional rate. Although our fees are calculated at a daily rate, you are still required to commit to the whole month. The monthly fee is based on the number of operational days including Statutory Holidays within the month. The Centre reserves the right to make changes during the year. A month's notice will be given prior to any changes.

The 2025 child care fees are as follows (School-age fees are effective February 1<sup>st</sup> 2025):

A \$200 per child advance fee for Kindergarten and School-age for children attending the Dublin Heights CCC Summer Program (This fee will be charged in May and applied towards your summer fees).

Advance fee (all groups) to maintain your spot for September (for families not attending the Summer Program) is \$250.00 or \$125 for one month, per child (This will be charged in June, is non-refundable and is applied towards your September fee). No refund will be given if families withdraw from the Centre with less than 30 days notice prior to the start of the school year.

A non-refundable registration fee of \$50 per child, or \$22 per child for CWELCC-eligible children, will be charged for new registrants.

An advance fee for new families of \$250 per child will be charged during the registration process (This fee will be used towards your first month's fee). No refund will be given if the family opts out after the registration process is complete.
