



**Dublin Heights Community Child Care Inc. 2026 Fee Memo**

DHCCC has applied and have been approved for the Canada-Wide Early Learning and Child Care (CWELCC) funding for our families with children 6 years and under. The 2026 CWELCC fee for eligible children will continue to be 52.75% reduction of the 2022 fee to a minimum of \$12.00 per day except for our Toddler program. Based on the new policies, daily rates may not surpass \$22.00, which means there are further reductions for that age group.

Please be advised that there will be a 3% increase of fees for our **School-age programs** starting January 1<sup>st</sup>, 2026 to cover annual inflation. There is a non-refundable registration fee of \$50.00/child for child/ren over 6 years of age (Without CWELCC). There will be a fee for non-instructional days (PA days, March Break, Winter Break and Summer). Although, our fees are calculated at a daily rate, all parents are still required to commit to the whole month. The monthly fee is based on the number of operational days including Statutory holidays within the month. If parents opt out of non-instructional days, parents are still responsible for the instructional day's daily rate.

The Centre reserves the right to make changes within the year. A month's notice will be given prior to any changes.

(For the Toddler, Preschool, Kindergarten and School-age children under 6 years, the applicable for 2026 are noted in column With CWELCC)

\*Kindergarten and School-age advance (July and/or August) for children attending DHCCC Summer program will be \$200.00/child and will be deducted in May. (Fees will be used towards the summer fees)

\*\*September advance (all age groups) who will not be attending the Summer program will be \$250.00/child and will be deducted in June. (Fees will be used for September). NO REFUND will be given if families withdraw from program less than 30 days prior to the start of the school year.

\*\*\*Parent advance will be \$250.00/child for all new registered families. (Fees will be used towards child's first month.) NO REFUND will be given if parents change their decision less than 30 days prior to start date.

\*\*\*\*All rates are determined upon staffing and extracurricular activities for each group. Kindergarten and School-age children are reminded to bring their own snacks and lunches during non-instructional days.
